**PAYMENT TERMS:** Total fee agreed upon by Client and Deligance LLC is  . Deligance LLC is holding a tentative reservation for Client's event until 5 days after the below "Contract Date". To confirm this agreement, return one signed and completed copy of this contract along with a deposit of \$150.00 within 5 days. Agreements received after 5 days from the contract date are subject to availability. The balance is due no later than 10 days prior to the date of the event and can be paid in cash, check or money order. All checks should be made payable to Deligance LLC. **Any unpaid balance must be paid prior to the date of the event.**

**OVERTIME COST:** When feasible. Client requests on the day of the event for extended use of The Chocolate Fountain will be accommodated. Overtime requests may be made by hour increments at a cost of \$50.00, \$60.00 or \$75.00 according to package purchased per hour. Payment for overtime is due at the time of the request.

**CANCELLATION:** The Client understands that this agreement can only be cancelled in writing, by either the Client or Deligance LLC. Cancellation by Client must be in writing to Deligance LLC and deposits will only be refunded if cancellation is made 60 days prior to the event date. The liability of Deligance LLC perform said services is subject to proven detention by illness, accidents or any other actions not under its control.

**PROVISIONS** Deligance LLC will require access to the desired set up area at least 30 minutes prior to the scheduled start time and 30 after the conclusion of our service, for set up and take down. Client is responsible for providing a sturdy, level table capable of supporting The Chocolate Fountain and additional food items. **Deligance LLC** requires at least one 120 volt circuit within 10 feet of the desired set up area. For health reasons, Client cannot take "left over" chocolate to go. Client accepts full responsibility and is liable for any damages, injuries or delays that occur as a result of failure to comply with these provisions.

**LIABILITY:** This Agreement and the contents hereof represents the only warranties, express or implied, between the parties, including any implied warranty or merchantability or fitness for the particular purpose and for any other obligation or liability on the part of **Deligance LLC**. **Deligance LLC** shall not be liable for any injury, loss or damage directly or consequently arising out of the use or inability to use The Chocolate Fountain, whether used singularly or in conjunction with any other equipment. Client will indemnify **Deligance LLC** against, and hold **Deligance LLC** harmless from all claims, actions, proceedings, costs, damages, and liabilities, including attorney fees, arising out of, connected with, or resulting from the use of The Chocolate Fountain.

**CHECK POLICY:** If your check is returned, NSF, it may be re-presented electronically, and you will be assessed a processing fee of \$20-30 or the maximum amount allowed by law. The Check writer is also responsible for all other check recovery costs, including all attorney's fees, court costs, and taxes.
